United Way: OC Free Tax Preparation







Orange County United Way partners with IRS, nonprofits, and local businesses to provide the OC Free Tax Prep campaign to qualified families and individuals in Orange County.

For United Way's free tax filing services, please keep these points in mind: You must have earned less than \$60,000 in 2019. If earning less than \$56,000, you may also be eligible for the Earned Income Tax Credits (EITC) and could receive over \$6,000 cash back.

There are two ways to get free tax filing with the OC Free Tax Prep Campaign: **Online**: This is the only free national online tax filing product offered by a non-profit. **With Support**: Schedule an appointment with an IRS certified volunteer.

To prepare properly, follow this simple checklist: Picture ID, Social Security card or ITIN letter for all individuals listed on the return, W-2s, 1099s and all other tax-related documents for 2019, Form 1095-A or B, or C health insurance coverage statement, all 1098-E and T forms for educational expenses, childcare provider name, address, phone number, and Tax ID number, bank account number and routing number for direct deposit refund, copy of 2019 Income Tax Return, and both spouses must be present to sign forms for joint returns.

Once you've filed your taxes, be sure to keep a copy of any forms you used to prepare your taxes, as well as a copy of your tax returns going back seven years. This information will make filing easier next year.

FSS Reimbursement

OCHA has an enhancement program to assist FSS participants who have demonstrated progress toward meeting their goals. The following are reimbursable out of pocket expenses per fiscal year (July 1st to June 30th):

Child Care expense: maximum \$1800.

Reimbursement is limited to participants who attend school or work full-time, or a combination of the two totaling full-time. Children under the age of 13 only.

Educational expense: maximum \$400.

For tuition, textbooks, class material, lab fees, testing fees, parking, and etc.

Emergency automobile repair: maximum \$300.

Vehicle registration/DMV fees, tune-up, oil changes or other; maintenance work **is not** eligible, only for emergency situation.

Prepaid Value Card: maximum \$100; \$50.00 per issuance.

When an educational goal is completed, a prepaid card is awarded when requested and may be utilized to purchase education and/or employment related items.

Bus Pass expense: maximum \$540.00; \$45 per month.

To assist with transportation for employment and/or school.

Note: Remember you must attend one workshop a year to access this benefit.

Graduation requirements: To graduate from the FSS Program, a participant must: Be independent of welfare (commonly referred to as CalWORKs in the state of California) for the last 12 consecutive months of the COP, seek and maintain suitable employment of 32 hours per week, and complete all interim and final goals listed on the ITSP prior to the expiration of the COP.
